Sealed Tenders are invited for the supply of the following photographic equipment for the Photographic unit of District Police office, Kochi City.

The tender forms are not transferable. Date and time of closing the Tender forms will be on 03.08.2017 at 04.30 PM. Last date and time of accepting tender forms is 04.08.2017 at 03.00 PM. The Tenders will be opened on 05.08.2017 at 11.30 AM. Cheque, draft/postal order and postage stamps will not be accepted towards the cost of the tender forms and tender forms will not be sent by VPP either. Duplicate tender forms if required will be issued at Rs. 750/- including VAT per copy.

The envelope containing tender should be prescribed "Tenders for Supply of Photographic Equipments for District Police Office, Kochi City" with Tender number and addressed to the District Police Chief, Kochi City - 682 011. The tenders will be opened at 05.08.2017 at 11.30 AM. in the presence of such tenderer or their authorized persons who may be present at that time.

1. Every tenderer should remit 1% (one percentage) as EMD ie, 7410/- in favour of the District Police Chief, Kochi City - 682 011 through DD or cash remittance in this office.
2. The Tenders should enclose an agreement as prescribed in the tender forms in stamp paper worth Rs.200/-
3. The successful tenderer should sign an agreement in stamp paper worth Rs. 100/- and deposit 5% value of the contract as security deposit .
